### Stefan Schnorr

Director-General for Digital and Innovation Policy at the Federal Ministry for Economic Affairs and Energy



Stefan Schnorr (58) has been working at the Federal Ministry for Economic Affairs and Energy since March 2010 and has been heading up the Director-General for Digital and Innovation Policy since April 2015. Prior to this, he worked in several other divisions of the Ministry.

Mr Schnorr is a legal expert. He started his career as a judge at the administrative court in Trier, before working at the Rhineland-Palatinate Ministry of Justice in Mainz where he headed up the public relations division and served as press officer.

In 2001, he joined the Representation of Rhineland-Palatinate to the Federal Government and the European Union in Berlin. From 2009 to March 2010, he served as head of the Representation of Lower Saxony to the Federal Government in Berlin.

Mr Christoph Winterhalter is the Chairman of the Executive Board of DIN, the German Institute for Standardization. Before joining DIN, he spent more than 20 years in industry working for the ABB group. He initially worked in various engineering, R&D and product management functions in Germany, Norway and the USA before he was appointed as responsible business unit manager for ABB's robot automation and robotics products business in Germany. In 2010, he changed to ABB Corporate Research as director of the German Research Center until he was promoted head of ABB's global Machinery Controls and Automation Business end of 2013.

In July 2016, he joined DIN as Chairman of the Executive Board driving customer orientation and digital transformation within the standardization system by encouraging all internal and external stakeholders to be openminded and open for change in order to shape the future with standardization. Mr Winterhalter was elected as member of the CEN Administration Board and the ISO Council in 2017. Since 2018, he has also been CEN-Vice President Policy including strategy development. In September 2021, Mr Winterhalter was elected as new ISO-Vice President Policy. In this position he will be responsible for ISO's Policy and Strategy. He will take on this additional role from 1 January 2022, initially for two years.


